Walkthrough for Just Legal and Just Politics Platforms

Introduction

User Journey: Just Legal

Step 1: Welcome and Onboarding

Upon accessing the **Just Legal** app via web or mobile, users are greeted with a brief introduction explaining the purpose of the platform: to assist individuals in navigating legal processes, whether they are pro se litigants or individuals seeking to understand legal matters more deeply. The onboarding process walks users through the app's key functionalities, highlighting its ease of use, conversational AI assistant, and legal flowchart guidance.

- **Key Message**: Legal empowerment through simplified, accessible resources.
- **Interactive Elements**: Users can select categories of legal assistance (e.g., civil, criminal, domestic) to tailor their experience from the very first interaction.

Step 2: Legal Process Flowchart

After onboarding, users are presented with a **legal flowchart** feature that outlines their potential legal journey based on their selections. Step 3: AI-Assisted Legal Assistant

Step 5: Document and Case Management

Users can save important documents within the app, create a timeline of their case, and track their progress. This feature allows for seamless organization, as users can return to their case at any time to update details, add notes, or upload new files.

- **Key Message**: Empowering users with the tools to manage their own legal cases.
- **Interactive Elements**: Upload and document storage features are intuitive, allowing users to categorize and tag their legal documents for easy access.

User Journey: Just Politics

Step 1: Welcome and Political Value Alignment

Onboarding for **Just Politics** begins with a political alignment questionnaire, designed to help users discover which candidates and issues align with their personal values. The app takes users through a series of weighted questions about key political issues such as healthcare, taxation, and environmental policies, using their answers to create a personalized profile.

- **Key Message**: Helping users align their votes with their values through simple and clear questions.
- Interactive Elements: The questionnaire allows users to select their level of agreement or disagreement with specific political issues, with instant feedback on how their values compare with existing candidates and political platforms.

Step 2: Personalized Dashboard
