Work Plan

This work plan outlines the key activities, responsible personnel, and timeline for the successful development and implementation of our two apps: **Just Legal** and **Just Politics**. - 3. Cross-platform Availability: Both apps will be developed for iOS, Android, and web browsers to ensure accessibility across devices and for diverse user groups.
